In 2018, India Austria bilateral trade crossed Euro 1.87 billion (+18.35%) mark as compared to the corresponding period the previous year. Trade deficit of India is diminishing over the years due to gradual decline of Austrian export to India. India's exports to Austria increased by impressive growth rate of 14.55% during the reporting period with a rise in exports of following top category products:

Nuclear reactors, boilers, machinery and mechanical appliances; parts thereof (35.37%), Organic Chemicals (38.16%), Pharmaceutical Products (217.08%), Articles of apparel and clothing accessories not knitted or crocheted (12.68%). However, other Made Up Textile Articles and Textile Articles export registered negative growth (-10.95%). On the other hand, Austria's export to India has also been increased by 22.32% during the same period. Austria's top ranked exported products increased Nuclear reactors, boilers, machinery and mechanical appliances; parts thereof (30.5%), Iron and Steel (74.26%), Beverages, spirits and vinegar (253%), Articles of Iron and Steel (63.61%). Similarly,

negative growth has been observed in Railway or tramway locomotives, rolling stock and parts thereof; railway or tramway track fixtures and fittings and parts thereof; mechanical (including electromechanical) traffic signalling equipment of all kinds (-23.81%), Plastic and articles thereof (-8.98%).
