Overview of India's Biotech Landscape

India's biotechnology sector is a critical driver of economic and technological growth, holding approximately 4% of the global biotech market. It has notable strengths in vaccines, bio-pharmaceuticals, and agricultural biotechnology. The sector is divided into bio-pharma, bio-services, bio-agri, bio-industrial, and bio-informatics, with bio-pharma at the forefront. India is a major supplier of DPT, BCG, and measles vaccines, contributing around 60% of the global demand.

India's bio-economy industry has grown from US\$ 10 billion in 2015 to US\$ 130 billion in 2024. India's bioeconomy contributes 2.6% to India's GDP, as of 2021. India's bioeconomy is poised to reach US\$ 300 billion by 2030.

India and Austria are well placed to collaborate in the biotech sector. India's cost-effective R&D, biopharmaceutical production, vaccine manufacturing, and growing start-up ecosystem are a perfect match for Austria's high-end R&D expertise, biotech clusters, sustainable practices, and focus on personalised medicine. The key areas in which the two countries could collaborate include drug discovery, vaccine development, personalised medicine, green biotechnology, clinical trials, and fostering cross-border start-ups.
