Instructions/Guidelines for the firms submitting proposals against this 'Expression of Interest' (EOI)

1. DISCLAIMER:

Indian Railways reserves the right to not proceed with the process or to change the process at a later stage as per the requirements of Indian Railways. It also reserves the right to decline to discuss the process further with any party submitting the proposal.

This EOI shall not be considered in any way a proposal for procurement of Rail Cum Road Vehicle (RCRV) based ultrasonic system but only for identification & verification of eligible OEMs/Authorized Service providers willing for Ultrasonic testing of Rails and Welds in Indian Railways, through outsourcing using Rail Cum Road Vehicle (RCRV) based ultrasonic system.

The proposal submitted should satisfy the Technical specifications described in **Annexure-C**.

The intending participants will furnish proposals at their own cost and no claims, whatsoever; in this reference, will be entertained by the Indian Railways.

2.PURPOSE OF INVITING EOI:

The purpose of this EOI is to enhance the capability of Ultrasonic testing of Rails & Welds in Indian Railways, using Rail Cum Road Vehicle (RCRV) based ultrasonic system through outsourcing model.

With the above objective, Indian Railways seeks to establish a system of multiple capable vendors for Rail Cum Road Vehicle (RCRV) based ultrasonic system, duly meeting the prescribed technical specifications requirements for their possible use on the Indian Railway network.

3.GENERAL INSTRUCTIONS FOR SUBMITTING PROPOSALS TO THE EOI:

3.1. Eligibility criteria:

3.1.1. Rail Cum Road Vehicle (RCRV) based ultrasonic testing system offered by the OEMs/Authorized Service providers should meet the laid down requirements of Technical specifications as described in **Annexure-C**.

3.1.2. Rail Cum Road Vehicle (RCRV) based ultrasonic testing system proposals not meeting the above laid down requirements shall be summarily rejected without further consideration.

3.2. The offered Rail Cum Road Vehicle (RCRV) based ultrasonic testing system should be a proven product/system, and the firm shall provide the details of testing and its performance for the previous three years and current ongoing year on any of the World Railway in the following format.

Above details regarding work experience should be duly certified by the competent /authorized officials of the concerned/respective Railway network.

*Performance of Rail Cum Road Vehicle (RCRV) based ultrasonic testing system can be attached as separate documents while submitting the EOI proposal. The firm may furnish other documents such as lab reports, field reports etc. detailing features /capabilities of their systems.

- 3.3. Technical details to be provided by the firm:** Technical details, as per the Technical Specifications given in **Annexure-C**, shall be submitted by the firm along with their proposals. Incomplete proposals shall be summarily rejected.
- 3.4.** The details submitted by the firm shall be scrutinized by RDSO. The deficiencies, as observed in the proposal during technical scrutiny or additional information needed as considered necessary, will be advised to the firm. The additional information should be made available by the firm within four weeks of intimation. Letters will be issued to the firms on the firm's e-mail as advised by them in their submitted proposal.
- 3.5. Submission by firms:** The firm shall ensure the submission in the format given in **Annexure- B**.
- 3.6.** The submission by the firms shall be made to Director/Track-V, RDSO, Track Design Directorate, Anusandhan Bhawan, Manak Nagar, Lucknow (INDIA) - 226011 in the enclosed Format for "Letter of Response at **Annexure B**". In the proposal submitted, the firms should mention RDSO's Notice No. CT/USFD/EOI dated 23.01.2025
- 3.7.** The firms must furnish the application form and details in duplicate as required in the enclosed Format for "Letter of Response" at **Annexure-B** and details stipulated in **Annexure-C**. All pages of the documents should be signed with the firm's stamp.
